Minutes

- Brief Review of revised TCS grant applications with minor discussion. Revisions discussed approved.
- Lower Cape Community Development Corporation DBA Community Development Partnership (CDP)Lower Cape Housing Institute. Amanda Bebrin represented the LCCDP to respond to questions regarding
 participation by town members and how the CDP planned on using the grant funds. Amanda outlined

- The same question regarding verbiage was asked regarding the FY 2025 cemetery restoration project and how/if/where that should also be included.
- Affordable Housing Trust- Housing. It was decided that Jim and Mary will develop a spreadsheet with
 the anticipated grant amounts and the resulting ending balances for the undesignated funds and for
 the open space reserve. The Committee may recommend to increase the grant amount to the AHT
 from 60% to 80% of this year's annual revenue and fund all remaining grant requests utilizing the
 current undesignated funds along with the reserve for open space.



 The three housing grant applicants (Brewster affordable housing, Community Development Partnership & the Truro Housing Trust) will be requested to attend the February 1st meeting to address the final concerns and questions of the committee before the vote. All other applicants are welcome to attend the meeting if they wish.
