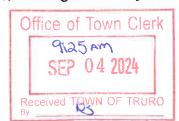

6.1 Superintendent:

Advisory Services Program

Stephanie Costigan announced that TCS has been accepted into an Advisory Services pilot program for which it was proven to be a good candidate in that the School has four buses. Follow ups include a meeting and signed letter of commitment with a preliminary needs assessment coordinated with the Cape Cod Collaborative and the Town of Truro, and an electrification analysis. Zero Emissions Vehicle Policy is under the jurisdiction of the Cape Cod Collaborative.

Nauset tuition agreement amendment

TCS presently covers students attending Nauset grades 7-12 at a cost of \$20k per student; while students who opt out of TCS for grade 6 are not covered. However, the State is now mandating these students remain as School Choice designated at a cost of \$5,000 per student. Stephanie Costigan said Nauset will reimburse TCS for \$45,000 for nine 7th grade students. Question was raised if TCS would prefer that Nauset prorate costs each year, or plan for reimbursements.

A motion was made by Pete Cook to approve the Nauset Tuition Agreement Amendment as presented, seconded by Arny Costa, roll call, 4-0-0.

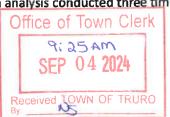

6.2 Principal Report:

End of the year wrap-up

Patrick Riley spoke of completing year one of the five year NOAA Guardian School Program plan, marine debris. Recognition was received for the Wellness Initiatives and sustainability efforts through the Mass Farm to School program. A group of teachers and staff participated in the Literacy Institute as well as the Social, Emotional & Behavior Academy. MAP Growth MATH 2022-2024 chart was reviewed indicating, through analysis conducted three times a year - fall,



winter and spring - improvement similar to that of MAP Growth Reading 2022-2024. Growth from winter to spring can appear lower in cases where hgh achievement has already been demonstrated. F&B BAS 2022-2024 show nearly double the number of students performing at levels Above Grade for grades K-5, when compared to benchmarks.

Capital improvement and Community Preservation projects highlighted, including the pre-K playground, HVAC, roof and security system upgrades, with results expected in 1-2 years.

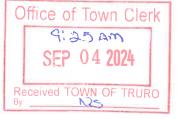
