5.1 Superintendent: Surplus, Grants, contract with the Collins Center and Town of Truro for budget planning, Preschool playground, Cape Cod Healthy

Connections and the Cape Cod Municipal Health Group

Surplus

Inventory revealed older desktop computers, non-working monitors and printers, out of date testing materials and used books.

A motion was made by Ken Oxtoby to approve that the surplus materials as presented be de-acquiesced by the School Dept., seconded by Tyler Medley, roll call, 5-0-0.

Grants

The Title One Federal grant has been secured for \$29,975.; \$10k for Title 4 for Social and Emotional Development, and \$3,404 for Title 2A. Funding focuses primarily on reading and math. 240 and 262 grants under the Individuals with Disabilities in Education Act were awarded in the amount of \$43,708 in total, which is on par with previous years. Just under \$5k has been awarded for the Fresh Fruit and Vegetable Grant for the Cart, introduced last year.

Awaiting notification on the Rural Aid Grant and \$30k from the Comprehensive School Health Services Grant. Heather Harper has reapplied for the Northeast Food for Schools Grant. The \$100k roofing and HVAC grant is good through the end of 2026.

Collins Center, Town of Truro Budget Planning

Professional Service Agreement, in contract with the Collins Center for Municipalities Management Services, set at an hourly rate, but not exceeding \$17,500, to create a public presentation regarding pupil expenditures that is easy to understand, digest and express. It was noted that the Town is also under contract to Collins.

Preschool Playground

Demolition to start the week of August 19th, wood chips and grading of the playground, all else rubber surfacing, primarily blue and greens for new equipment, four swings and a large sandbox, riding track and seesaw. Shaded area maintained as before, but with no new shading areas due to budgeting.



<u>Cape Cod Healthy Connections and the Cape Cod Municipal Health Group</u>
Truro School being sought as a Lower Cape location for the Healthy Connections programs via adult health ed classes.

Pete Cook asked if there will be progress check-ins along the way as relates to the work being contracted out with the Collins Center. Superintendent Costigan will ask Alex to attend the next TCS meeting to address these concerns, as well as how the fee is split between the School and the Town.

Pete Cook requested to touch base in terms of alternate recycling spots for the discarded surplus items in the Surplus inventory.

5.2 Principal Report: Ocean Guardianship, part-time contracted EL teacher

Year one NOAH Ocean Guardian program has been completed, banner to be displayed along with packet letter in the lobby; year two will also feature marine debris and expand to include more community family outreach. 5-year project.

Part-time EL teacher Jennifer Fellowes (sp), hired as an independent contractor.


5.3 Admin. Business & Finance: Financial update, Line transfers, Cafeteria budget

Heather Harper addressed the final FY2024 101 Financial Statement with totals returned to the Town in the amount of \$497,077.53; 7-12 Tuition, \$134,110.30; SPED Tuition, \$257,679.30; Encumbrance (Collins Center), \$17,500; Wage/Non-wage, \$87,787.93.

FY2024 Line Transfers: Kindergarten Teacher Salary, \$20,876.00; Internet Services, \$4,528,00

A motion was made by Ken Oxtoby to transfer \$25,404 between accounts as identified and requested by the Finance Director, seconded by Pete Cook, roll call, 5-0-0.

Cafeteria Budget, year-to-date at \$168,338, for a net profit of \$2,150. Vida Richter asked if healthier choices in the student diet can be facilitated within the School budget. Heather Harper said some frugal expenditures can be made within the slim balance maintained, and funds can be sought from the Fresh

Fruit & Vegetable Grant. Vida Richter said she hoped that breakfast offerings can provide more protein-oriented foods such as hard-boiled eggs, and less packaged items. Superintendent Costigan said there will be more options and highlights for students going forward such as a selected Item of the Month.
