- 4. Review and approve CAC 2024/25 goals: APPROVED with changes below.
 - a. Prioritized Goal 2 completed (approved the Charge)
 - b. Prioritized goal 3: add divestment from fossil fuels and fertilized as town warrant articles
 - c. Prioritized Goal 4 (cooperate with Energy committee and other CACs in Wellfleet, Provincetown and Eastham: Lili will get me the contacts for Wellfleet/Provincetown/Eastham CACs and we will try set up a joint meeting of Truro Energy Committee and CAC.
 - d. Ongoing goals approved
 - e. Stretch goals approved consider adding avoiding fertilizers.
 Difficult/impossible to enforce. We can suggest proper fertilizers. Add an article on the town warrant. Or add to town warrant articles under Prioritized goal 3.

- Review and discuss Phase One of the Truro Climate Action Plan: WE WILL STICK WITH THIS PLAN AS IS SINCE IT HAS BEEN APPROVED.
 - a. Approved by Select Board*, but the only copy says "DRAFT".
 - b. Need to run it by the Select Board to remind them and move it forward. Stephanie Reim has been asked to check with SB on how to move this forward. Lili sent an email, but no response.
 - c. Need to figure out how to coordinate this with the Energy Committee.
 - d. Can we adjust this or since it is approved is it "final"? For now we will leave it as is.
 - e. Discuss the CAP with the Energy Committee (and the Climate Coordinator) when we get a joint meeting.
 - f. We are already doing much of what we have been "assigned". Really need a Climate Coordinator to move this forward.
 - g. Add Public forums to CAP? We are already doing this with the Library meetings and postings on the website.
 - h. Consider publishing/posting a list of what we are doing now so that the public sees progress.
- 7. Updates on Climate Coordinator: interviews being done on October 28. Will try to add Alex as well. There are 8 candidates.
- 8. Katie Riconda by Zoom: Needs the information for the publication by the 3rd
