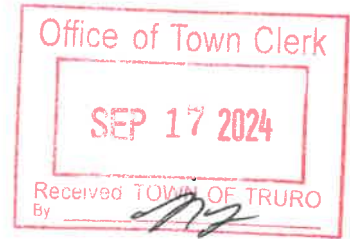


TRURO SCHOOL COMMITTEE MEETING

1. Call to Order: Vida Richter called the meeting to order at 4:31pm.

5.1 Second reading of Policy sections [I](#), [J](#), and [ZEV First policy](#) -

Ken Oxtoby noted two versions of policy JLC as exists: one undated, and one dated 2021, which, he said, are either identical or very close. Amy Costa questioned the phrasing of IC/CIA pertaining to 185 schooldays, which Superintendent Costigan confirmed includes five professional development days. Tyler Medley asked about the section related to remote learning IHBHE, which was introduced in 2020 with the advent of the COVID-19 pandemic. Pete Cook asked what is specifically required from the TSC for a policy vote, to which Superintendent Costigan said a letter from her office confirming TSC approval is required based on a third reading for a July 31st deadline, but that there would be more time available for the policy manual. Amy Costa made what she said was a minor point regarding IE, Organization of Instruction not utilizing consistent terminology, asked if a link to the Green Communities Act would be helpful, and mentioned the description of V. INVENTORY, MEI (Mass Energy Insight).

A motion to move Policy sections I, J and ZEV First Policy to a third reading was made by Ken Oxtoby, seconded by Tyler Medley. Roll call 5-0-0


