1. Call to Order: Terri Humes called the meeting to order at 5:15 PM.

2. Approval of Minutes: Michelle Jarusiewicz presented a motion to approve the minutes of January 8, 2019, second by Terri Humes, vote 2-0-1, Tim Dickey abstained.

4. Administrator's Reports

- **4.1 Superintendent's Report:** Mr. Gradone reported Cape Cod Light Compact is providing funding for RISE Engineering to write the bid specs for TCS boiler conversion. The plan is to put the project out to bid Spring 2019 with installation in August 2019. A plan which includes collaboration with neighboring towns has been submitted for the Rural Aid Grant. Nauset tuition enrollment projections for the next 5 years are attached. Mr. Gradone reported there is likely to be an increase in state aid in 2019 2020 FY. Cape Cod Times reporter Ms. Cindy McCormick is writing a story on demographics of the Outer Cape. The report will focus on housing, school enrollment and free Pre-K. Ms. McCormick interviewed TCS Pre-K teacher Ms. Lynne Ready, Mr. Gradone and Mr. Beaudet. Ms. McCormick also spent time in the Pre-K classroom. Mr. Gradone concluded his report with budget information from Town Manager Rae Ann Palmer. The Board of Selectmen has asked the TSC if the FY20 budget request might be reduced by \$100,000.
- **4.2 Principal's Report:** Mr. Beaudet reported the Bingo fundraiser held by the TEEA was a successful, pleasant community event. To date there has not been much interest from parents to participate as School Council members.
- **4.3 Director of Special Education Report:** Mrs. Costigan reported on results of the after school childcare survey. Majority of respondents had children ages 5 9. The survey strongly indicates cost as an obstacle in accessing childcare. Currently the Recreation Dept. charges \$6.00 per day, if child is preregistered, taking in approximately\$13,000. per year. Mr. Gradone and Ms.

Costigan recommend charging a fee which would provide some revenue while encouraging families to use the program responsibly.
